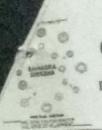

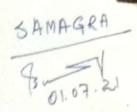

Subject: Modified procedure for release of funds to the State /UTs for Centrally Sponsored Scheme and monitoring utilization of funds released.

Sir.

The Gol, Ministry of Education, Department of School Education and Literacy vide D.O. No.: 4-4/2021-IS.2 dated 24-05-2021 informed that revised procedure of release of funds to the State/UTs for Centrally Sponsored Schemes and monitoring of utilization of funds shall be made effective from 1st July 2021.

Accordingly, the matter was taken with the Administrative Department for designation of Single Nodal Agency (SNA) under Samagra Shiksha Scheme vide No.: Edu/SPD/SmS/K/232/21 dated: 10-06-2021.

Vide Government Order No.: 1053-Edu of 2021 dated 24/06/2021, Project Director Samagra Shiksha has been designated as Single Nodal Agency (SNA) for implementation of Centrally Sponsored Scheme and as per terms and reference of the order following are required to be done.

- Funds available in the bank account of all the Implementing agencies
   (IAs) below SNA will be transferred to the bank account of the SNA
   concerned with clear bifure, tion of the Central and State Share.
- ii. Zero balance bank accounts of the IAs down the ladder will be opened in any scheduled commercial bank having robust IT system.
- iii. All the IAs will be registered in PFMS and their zero balance bank accounts will be mapped in PFMS.

You are therefore, requested to initiate the process of immediately transferring the funds from the accounts of the Implementing Agencies to the accounts of the Single Nodal Agency. It is worthwhile to mention here that the funds from the account of the Implementing Agencies shall be transferred to the account of the SNA through Chief Education Officer of the respective District.

To explain it further for your convenience the funds in a school shall be first transferred to the account of the concerned Zon. Education Officer and then from

The Chief Education Officers while transferring the funds to the account of the Single Nodal Agency (SNA) (To be intimated when process in district is completed) shall compile it along with funds lying with them. The exercises of transferring the funds from the accounts of Implementing Agency to the accounts of the Chief Education Officer and making the accounts of the implementing agency as ZERO balance account shall be completed within a period of 07 days as the deadline for transferring the funds to the SNA has already crossed.
