Whereas online applications for transfers and postings of Masters was invited by this Directorate on the grounds as mentioned in the transfer policy/circular instructions under reference through online mode on official website (<http://schedujammu.nic.in>) and SARAL DSEJ online Education android app;

Whereas in the circular the Masters were asked to submit particulars along with five choices of postings in order of preference in the application form;

Whereas after the analysis of application, it was found that substantial number of Masters have not submitted/uploaded the requisite documents in online mode to support their claim for consideration on the grounds for which they had applied;

Whereas the Masters were asked to submit the supporting documents required as per Transfer policy/circular instructions under reference for consideration of their application under the grounds in which they have applied for transfer in online mode vide circular No. 48 of DSEJ 2021 dated 19-04-2021. In the notification Masters were initially asked to submit these documents till 25-April-2021, which was later extended;

Whereas after submission of the required documents a tentative transfer list of Masters was prepared and made public on Official website of directorate vide notification no 746 DSEJ of 2021 dated 17-07-2021;

Whereas the Masters in the tentative transfer list were asked to submit objections, if any, to the same in online (on official website and SARAL dsej online education app) as well as offline mode whichever convenient within seven days from the publication of notification which was later extended;

Whereas 1091 objections as received were reviewed and where ever necessary adjustment/correction in the tentative transfer list was made/done after taking into consideration the choices given by the Masters along with supporting documents under which the Master had applied and considering the vacancy position, interest of students and in the interest of administration,




