ORDER

- 1/ That the Drawing and Disbursing Officers will ensure that Officer/official shall not avail un-authorized leave/study leave during the study period, Moreover the School work shall not suffer.
- 2/ That in case the documents submitted is/are found fake or forged the Drawing and Disbursing Officer will be personally responsible.
- 3/ That the Drawing and Disbursing Officers will be further personally accountable for any financial lapse, in case at any stage, it is found that the Official has been paid for the period he/she was undergoing his /her regular class work in the University while being shown present in the Institution, with a view to ensure that nothing of this sort happen and the certificate from the concerned University/Head of the Department should be obtained certifying the period for which the official has attended the class work so that accordingly corresponding action of sanctioning of leave could be entitled to avoid in any irregularity/financial lapse.
- 4/ That the Drawing and Disbursing Officers will ensure that the entry of qualification so acquired should not be made on the Service book by the DDO till final sanction is accorded.
